#### **Foreword**

#### **Chairmans Report**

Welcome to Cookham Parish Council's Annual Report. It has been an interesting year.

Particularly sad news was the sudden death on 31 March 2025 of Cllr. Eileen Bune. Eileen was a hard-working, much respected and loved councillor, who had represented Cookham Rise since 2015. She will be sadly missed.

Our then Clerk gave notice in June and left in August 2024. We retained a Locum Clerk, Hilda Holder, with Jonathan Holder as a consultant. Our new clerk, Deepa Kanthi, started in November. We are grateful to all of them, and Christine Hunter our Assistant Clerk, for all their help during this difficult period. We have taken advantage of Hilda's and Jonathan's expertise and Deepa's commercial background significantly to modernise and streamline the Council's practices and procedures. We hope that this will be an ongoing process.

We have created a new website for the Council, with a new address: www.cookham-pc.gov.uk. The new website is brighter, easier to use and more comprehensive than the old, as well as easier for us to keep up to date. The Parish Office's and Councillors' e-mail addresses have changed accordingly. (Emails to the old addresses are of course forwarded to the new ones.)

As last year, one of the Council's major preoccupations this year has been the three planning applications for housing at Lower Mount Farm and Strande Park. These applications were not debated by RBWM's relevant committee until 19 December 2024. We made sure that Cookham's interests were advanced as fully and forcefully as possible. We retained planning and traffic specialists to help us and made a number of submissions.

We were deeply unhappy with the RBWM Planning Committee's discussions on 19 December and their decisions to allow all the applications. We succeeded in obtaining only minor changes and in our view the resulting developments (which will add some 10% to Cookham's housing stock) are far from ideal. We considered a legal challenge but the advice from our KC did not justify proceeding.

We shall continue our efforts to protect the special nature of Cookham. We are already deeply engaged in opposing a proposed crematorium in the important green belt off Long Lane.

As part of our efforts I am pleased to say that after a final consultation by the Parish, the draft Neighbourhood Plan has been approved by the Parish Council and sent to RBWM for its consultation and Examination. We hope for a referendum and approval in the summer of 2025.

Sadly, the progress Mark reported last year in our negotiations with the Environment Agency to restore access to Lock Island at Odney Common proved illusory. We shall continue our efforts.

The Byelaws governing the Moor and Odney Common have now been posted on each (on Odney Common in a new notice board). We have appointed an Officer to enforce them, liaising with the National Trust and Odney Estates. The Officer will also enforce our Rules in the Alfred Major Recreation Area where we have experienced some graffiti, minor vandalism and abusive behaviour.

As usual, we participated, with a stall and the presence of many Councillors, in the Scouts' Cookham Fair on Cookham Moor in June. We took part similarly in the Christmas Fayre in the High Street.

In October, I was pleased to host on the Council's behalf a reception in the Community Room in High Road to welcome the Maire of St. Benoit with their and our own Twinning associations.

Throughout the year it has been a pleasure to work with such good colleagues on the Council. Thank you to all of them for their good humour, patience, hard work and dedication to serving the people and Parish of Cookham. Thank you also to all those organisations, such as but not limited to the Cookham Society and WildCookham, as well as all the individuals who have worked with the Council during the year for the same purpose.

# **Committee Reports**

#### **Finance Committee**

The members are: Cllrs. R. Kellaway (Chairman), Brar, Caen, Edwards, Howard, Moore, Pleming and Regan

The Finance Committee is responsible for the setting of budgets, and it also oversees the finances and governance of the Parish Council including:

- Completing the annual budget, taking full account of the needs and requests of the General Purposes, Planning, Flood and Staffing Committees.
- Recommending a precept for approval by the full Parish Council to be collected from residents through RBWM.
- Overseeing the completion of the annual return and audit.
- Periodically reviewing the Parish Council's policies on such diverse matters as data protection, complaints and financial controls.

The budget for this year planned a small deficit of just under £12,000. There are ample reserves and we are advised to reduce them over time. There have been extra costs incurred to cover the resignation of the clerk and the need for temporary cover. Two experienced exclerks have assisted. Planning issues have required use of consultants and legal support. Revenue from extra burials has balanced out these extra costs so that the final accounts will be largely in line with the budget. The precept for the new year is an increase of 5% which forecasts a small deficit of £12,000 which is covered by reserves.

#### **CPC Planning Committee**

# Report for Year May 2024 - April 2025

Cookham Parish Council's Planning Committee has influence rather than power. We don't decide the result of planning applications- that is the Royal Borough of Windsor and Maidenhead's (RBWM's) job. However, we do provide key local input, informed by our extensive collective knowledge of Cookham and its community, into the RBWM's and others' planning processes.

This year has been a very busy year for us:

- Consultations We responded to consultations on the new Government's proposed changes to the National Planning Policy Framework (NPPF); the RBWM's proposed new Parking Policy and Biodiversity Action Plan; and consultations on the Southeast Transport Strategy, the River Thames Scheme, and the new Maidenhead Local Plan.
- RBWM We have been working with our RBWM councillors Mandy Brar and Mark Howard to ensure that that Cookham's voice in planning matters is heard fairly in the RBWM.
- Community We have liaised with the Cookham Society, Wild Cookham, and Friends of Cookham Abbey, amongst others, to improve the effectiveness of our Planning inputs.
   We've also liaised with the Maidenhead Advertiser to get our points across to a wider local audience.
- Major Planning Applications
  - Cannondown Road/Strande Park We spoke to the Maidenhead Development Management Committee to oppose the final plans for the Cannondown Road and Strande Park housing developments, because of issues with increased sewage spills, lack of accessible open space, increased traffic congestion, especially around Cookham Bridge, dangerous parking, and poor provision of public transport. To our disappointment, the plans were passed. However, we did win concessions on upgrades to Cookham's sewage system and bus service, and traffic monitoring. We are keeping up the pressure on the RBWM to try to ensure that Thames Water implement the conditions won on sewage system upgrades effectively.

- Proposed Crematorium We continue to oppose this completely inappropriate proposed development in part of the narrow area of Green Belt between Cookham and Maidenhead, off Long Lane, a mainly single track, rural road.
- Marlow Film Studios and Holland Farm Applications We spoke at the Public Inquiry to support Bucks County Council's decision to reject the application for Marlow Film studios. We drew the Planning Inspector's attention to the inadequate modelling of increased congestion on Cookham Bridge, and potential effect of increased sewage discharges from Little Marlow Sewage works on Thames pollution in Cookham. We also objected to the application for 400+ dwellings at Holland Farm in Bourne End, for the same reasons.
- Smaller planning applications We have considered and responded as appropriate with informed local feedback to an average of 10-15 Cookham planning applications per month.
   We have also supported groups of local residents, where appropriate, in requests for support for planning objections and enforcements.

The new Government's recent changes to the NPPF increase the requirements for Local Authorities to build even more houses in already overcrowded areas and weaken planning rules protecting the Green Belt. Following these changes, unfortunately, we expect an even busier year next year.

Key issues of concern are the implementation of the sewage system upgrade conditions on the Cannondown Road and Strande Park developments, the proposed Crematorium off Long Lane, and the Church Commissioners' declared intention to build 200 dwellings on Cemetery Field south of Cookham Rise, effectively joining Cookham to Maidenhead. The RBWM will also be starting to develop a new Borough Local Plan at the beginning of 2026, which potentially means more large developments for Cookham.

We look forward to the new Cookham Neighbourhood Plan, which will provide updated planning guidance specific to Cookham, hopefully being approved within the next year. There will be lots of work to do in the coming year, with available resource, including Parish Councillor time, also a concern for this committee.

We would like to thank Christine Hunter and Deepa Kanthi, our Clerks, and all our planning Councillors for all their support in the last year. Eileen Bune, with her common sense and long knowledge of Cookham's community, will be sadly missed. Many thanks to the members of the Cookham Neighbourhood Plan Working Party who have worked so hard to develop our Neighbour Plan. Many thanks also to Bill Perry, who stepped down last year as Chair of the Cookham Parish Council Planning Committee, Dick Scarff, who represents the Cookham Society on our committee. Jon Herbert, our planning consultant, and Simon Watts, independent traffic consultant, have provided invaluable expertise and help. We'd also like to thank all the Cookham residents, including Paul Strzelecki, who have shared their suggestions and concerns with us.

#### **GENERAL PURPOSES ANNUAL REPORT 2024-25**

All the trees in the Alfred Major Recreation Ground were surveyed and the necessary work undertaken to make them safe. This included removing boughs that were over hanging in neighbours' gardens.

An infestation of Oak Processionary Moth was found on these majestic oak trees and had to be dealt with as an emergency, as they can harm dogs and people with their mildly poisonous spines. Leaflets were hand delivered by a Councillor to all the homes that were affected and within days a tree surgeon was employed to remove all the caterpillar nests.



#### REFURBISHMENT OF ALL PARISH COUNCIL NOTICE BOARDS

It was difficult to read all the Parish Council notice boards due to cloudy Perspex and the name banners at the top were ripped. Rather than buying new ones, we gave them a successful make over.



#### NEW PARISH COUNCIL NOTICE BOARD AT ODNEY COMMON

We invested in a new noticeboard for Odney Common. This one is particularly important as it displays the byelaws. This allows any contraventions to be acted upon. This, and the new "not allowed" signs that we put up on the entrance to the Common were desperately needed as the summer of 2024 was particularly difficult with visitors leaving behind bbq rubbish and human faeces. This is unfair on other visitors and the local blacksmith who was unable to

exercise his Commoner rights and use the grass for hay making. We plan to add a map to the notice board, showing visitors the closest public toilet, which is just around the corner.





# CORONATION COMMUNITY ORCHARD PLANTED AT SUTTON ROAD ALLOTMENTS

A grant was successfully obtained to pay for 32 fruit trees to be planted in the Sutton Road Allotment field. This is a community orchard and will be open for at least one day a year for the public to enjoy. In addition, it is planned to pick fruit for local groups, such as the Elizabeth House care centre for the elderly.

A new tap was installed to water the trees and a hose and water chlorine remover were kindly donated by a Councillor. Essential for the health of young fruit trees.



# NEW SECURITY FENCE AND GATES AT THE ALFRED MAJOR AND SUTTON ROAD ALLOTMENTS

The allotments at Sutton Road reported produce being stolen from their plots. We installed a spikey fence which is very difficult to climb over. We hope to plant a Quick thorn hedge alongside this fence in November 2025, with the help of allotment holders. The allotments at the Alfred Major Recreation Ground requested that we reinstate a gate that was removed without consultation. This was done as it makes delivery of compost etc much easier. This gate also had a protective security fence added to it, as they often get teenagers climbing into the allotment and making a mess.



### WAR MEMORIAL CLEANED

The Cookham Village War Memorial and Tarry Stone seat were professionally cleaned. The Memorial was finished in time for the 2024 Day of Remembrance Day Service.




# NEW BASKETBALL COURT SIGN AT THE ALFRED MAJOR RECREATIONAL GROUND

The basketball court at the Alfred Major Recreation Ground is made of tarmac and meets safety standards. Following an inspection by the Royal Society of the Prevention of Accidents and under their recommendation we had a new sign put up at the side of the court to warn people of possible dangers.



### HEDGES ALLOWED TO GROW FOR IMPROVED HEALTH AND WILDLIFE

It was decided to allow the hedges around all the allotments to grow longer. This is to improve biodiversity and the health of the hedges.



# IMPROVEMENTS TO THE PONY FIELD AT ALLEYN'S LANE ALLOTMENTS

It was decided to invest in the pony grazing field at Alleyn's Lane Allotments. A water trough for the ponies was moved, a tap installed, and the rotten fencing has begun to be replaced.



#### NEW CARPET AT CEMETERY LODGE PARISH RENTAL

The house owned by the Parish Council is rented out to staff from the Bell & Dragon. It very much needed new carpets which were installed this year.

#### NEW HEDGE PLANTED AT ALLEYN'S LANE PONY FIELD

A grant from the Woodland Trust gave the Parish Council 240 saplings to plant alongside fencing at the pony field in Alleyn's Lane Allotments. Volunteers from Wild Cookham helped to plant the hedge which is a mix of native hedges good for wildlife. It was layered with hessian, mulch and wool to keep the water in the ground and make it drought resistant. The local blacksmith, David Matthews kindly donated straw mulch.



# REPLACEMENT PICNIC BENCH AT THE ALFRED MAJOR RECREATIONAL GROUND

Complaints were received of small children bumping and cutting their foreheads on an old metal picnic bench. We replaced it with a safer bench, made of recycled plastic.
